Sump Waste	\$64.00	Only Pre – approved de -watered sump waste with shipping document and access code.	Hauler or Account Holder

Clean concrete	\$17.25	Clean concrete with no other debris which is less than 2 foot in total size (larger concrete not acceptable)	Hauler or Account Holder
Asphalt	\$17.25	Clean Asphalt with no other debris	Hauler or Account Holder
Revenue Generating Cover	\$19.25	Contaminated soil that meets cover criteria.	Hauler or Account Holder
Clean Fill		Clean fill will be accepted on a pre approved basis. A one time pre approval fee of \$50.00 will be charged. Costs associated with analysis will be the responsibility of the hauler of account holder. A minimum fee of \$5.00 will be charged on every load	Hauler or Account Holder
Scrap Metals (excluding mixed loads)	\$60.00	All Scrap Metals (excluding small amounts in mixed residential loads and residential appliances Not from commercial hauler)	Hauler or Account Holder
White Goods and CFC Units	\$60.00	All Products, fridges, stoves, dishwashers etc. Must be drained prior to acceptance.	Hauler or Account Holder
Designated Materials (Tires, Electronics, Paint, Used Oil and Pesticide Containers)	N/C	Materials that are governed by Advanced Disposal Fees and governed by Designated Operating Authorities will be accepted at no charge if delivered in separate loads. Commercial generators of Used Oil and pesticide containers are excluded.	

NOTES:

- The tipping fee for mixed loads will be charged at the rate of the highest fee for any one of the materials contained in the load.
- A Minimum Charge is in effect for ALL Haulers at a minimum rate of \$5.00 per load
- Failure to pay disposal fees will result in the loss of dumping privileges.
- There is no charge for blue bags, tires, electronics, or paint or pesticide containers. However if these materials are delivered in a mixed load with other materials a mixed rate load will apply.
